Stryker's commitment to advancing IIS research goes beyond our Concierge program. We're here to help with useful information and resources to make the research grant application and submission process simple, convenient and efficient.

### We know you have questions. Here are a few answers to get the process started and keep your study moving forward.

#### How do I begin the research grant application process?

- Visit <u>www.researchgrants.stryker.com</u> and click the **Register for access** link on the left of the screen. This will take you to the **New User Registration** form.
- Submit the completed form to receive your temporary login credentials via email. Next, log in to your account and change your password. You may then create a new application request.

#### Is login access secure?

- Yes. For your protection, three incorrect username/password attempts will lock out access to the portal.
- If you forget your password or have problems logging in, contact <a href="mailto:support@steeprockinc.com">support@steeprockinc.com</a>
  to reset your password.

#### Do I need to submit a full protocol?

• No. You may initially submit an IIS concept. If Stryker decides to move forward with the study concept, a full protocol will be requested.

#### What documents are needed for submission?

- Current (signed/dated) CV
- Overall budget
- Concept or protocol information required in the application template
- Due Diligence checklist (to be completed via the portal)

#### How will I be informed about the status of my submission?

- Notifications of status and additional information requests will be sent via email to investigators and study personnel.
- All document submissions and updates should be completed via the portal to ensure ease of use, accuracy, transparency and efficiency.

#### If my study is approved, how often will I need to submit progress updates?

- Stryker asks that progress updates be submitted monthly. Such updates include enrollment, follow-up and publication/presentation plans.
- An email notification will be sent to study personnel designated in the portal once a 30-day period has passed since the previous update.
